## **Developmental minicamp**

**Cost:** Week 1: \$260 and Week 2: \$277

Week 1 classes will be 1.5 hours and will be held Monday-Friday. Week 2 classes will be 2 hours each time slot and will be held Tuesday through Friday. Players will be divided by ball color and grouped according to the most appropriate level based on enrollment. There will be 5 players per court, these are full week camps. Classes will focus each day on a variety of topics including fundamental athletic skills, proper stroke mechanics, footwork and movement skills, and gameplay.
